The Ralls County Commission signed a New Collector Contract for the Ralls County Collector Tara Comer.





The Ralls County Commission spoke to Terry Sanders via telephone. Mr. Sanders asked if Junior had received the pictures, he sent him.



The Ralls County Commission discussed Road & Bridge maintenance.





Punctuality and attendance are essential to the county's daily functions and operations. As an employee of Ralls County, we expect our employees to work their scheduled shift and provide ample notice when they cannot. Failure to report to work hinders not only the daily operations of the county but also the level of quality service we provide to the residents of Ralls County.

Absences

All employees are expected to report to work and be productive during their work shift. However, Ralls County understands that circumstances may occur when employees cannot report to work that day.

If there are any reasons that employees plan to report late for their shift or are unable to report for their entire shift, they are expected to alert a supervisor and/or secretary as soon as possible with a minimum notice of **one hour prior** to the start of the shift, 24 hours in advance is preferred.

Excused Absence

An excused absence occurs when an employee uses paid time off that was previously scheduled and approved by the supervisor.

Unexcused Absences

An unexcused absence occurs when an employee is absent from work and has not notified a supervisor and/or secretary before their scheduled shift begins.

Late Arrival

All employees are expected to arrive at work on time at the start of the shift schedule. If an employee is late, they must notify a supervisor and/or secretary as soon as possible.

Early Departure

All employees are expected to work the entire duration of their shift. If an employee cannot work the entire duration of their shift, they must notify a supervisor and/or secretary as soon as possible.

If you are scheduled for a shift and fail to clock in or have issues with the app you are deemed as on the clock for that shift.


