The Ralls County Commission discussed Road & Bridge maintenance.


David Bunge, Azimuth Renewables called into commission meeting at 11:30 am to discuss the Road Use and Maintenance Agreement.

The Ralls County Commission looked over and discussed possible new Planning & Zoning Order.


The Ralls County Clerk let the Commission know she received confirmation from the State Auditors office acknowledging receipt of 2024 Budget.
