Proposition Innovation

Shall the Board of Education of the Hannibal School District No. 60, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Thirty Million Dollars (\$30,000,000) for the purpose of providing funds to construct, equip, and furnish the Hannibal Innovation Campus; to complete Middle School and High School Auditorium renovations; to upgrade the Porter Stadium concession stand, restrooms, and bleachers for ADA compliance; to prepay existing lease financings; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1.1200 per one hundred dollars of assessed valuation of real and personal property.

Shall the Board of Education of the Hannibal School District No. 60, Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Thirty Million Dollars (\$30,000,000) for the purpose of providing funds to construct, equip, and furnish the Hannibal Innovation Campus; to complete Middle School and High School Auditorium renovations; to upgrade the Porter Stadium concession stand, restrooms, and bleachers for ADA compliance; to prepay existing lease financings; to the extent funds are available, complete other repairs and improvements to the existing facilities of the District; and issue general obligation bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$1,1200 per one hundred dollars of assessed valuation of real and personal property.
