



Ralls County Commission discussed road maintenance with Danny Clark, Road and Bridge Supervisor.


Poepping, Stone & Bach Associates, Inc. presented a plaque to the Ralls County Commission for completion of Ralls County Bridge #04000091.

The Ralls County Circuit Clerk, Gina Jameson presented the Circuit Court Disbursement Listing for the month of March.





Larry Dougan from Missouri Association of County Transportation Officials attended the Commissioners meeting.






