Commission will meet again on August 6th, 2018, unless convened by court.

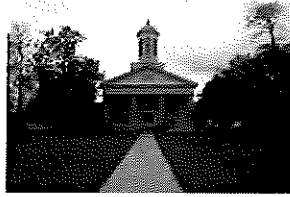



The Ralls County Commission signed accounts payable as listed in the warrant registry.






