Jim Thompson met with the Ralls County Commission about the Saddle Club.


The Ralls County Commission received an ordinance from City of Center in regards to annex a property into city limits.







Jon Dwiggins from Howe & Company Engineering met with the Ralls County Commission.


John Lake made a motion to do 3 corners of the county for the fiscal year 2020 with the re-monumentation program. RC seconded the motion. Motion passed.
