The Ralls County Commission met with Harry Hosmer and Lori Rickey concerning a Planning and Zoning issue.


Wiley Hibbard made a motion to hire Anthony Galluzzio for the Road and Bridge Department. John seconded the motion. Motion passed.


Mary Howald meet with the Ralls County Commission and voiced her concerns with the Sheriff Office.



The Ralls County Clerk, Sandy Lanier, presented the sales tax distribution for the month of July 2020 to the Ralls County Commission.




