Sydenstricker-\$7,700.00


Wiley Hibbard made a motion to purchase the 8ft blade from John Deer Sydenstricker Implement Co. John Lake seconded the motion. Motion passed.

The Ralls County Commission received the cash receipts journal for the month of November 2019.


