
Marty Wasson met with the Ralls County Commission about the flood plain survey. Marty advised the ground level have not changed.



The Ralls County Commission received the Cash Receipts Journal for the month of November from Treasurer, Jena Epperson.


The Ralls County Commission renewed a cylinder lease with ILMO.
