

Wiley Hibbard made a motion to purchase winter apparel for Ralls County custodians. John Lake seconded the motion. Motion passed unanimously.



**The Ralls County Commission reviewed and discussed the American Rescue Plan Act (ARPA).**



**Wiley Hibbard made a motion to raise Shane McClelland's pay to \$1,500 per month. John Lake seconded the motion. Motion passed unanimously.**


