**The Ralls County Commission signed accounts payable as listed in the warrant registry.**





**John Lake made a motion to put CDAR'S with Saint's Avenue Bank because they paid the highest interest. RC Harlow seconded the motion. Motion passed.**


**The Ralls County Commission signed a letter for the proposed annexation by the City of Perry for the right-of-way along Hwy 154.**






