John lake made a motion for Junior Muehring to become the liaison for the Ralls County Extension Council. Wiley Hibbard seconded motion. Motion passed.





#### **County Revenue Fund**

**Now on this day the balance on hand for the County Revenue Fund is \$340,625.30 with the estimated 2021 revenues of \$2,712,160.00. The total estimated funds available for 2021 are \$3,052,785.30. Estimated 2021 expenditures are \$3,052,348,65. The proposed budget was based on tax levy of \$.2778 on the valuation of \$266,940.469 which will produce \$741,561 in revenue.**

#### **County Road and Bridge**

**Sheriff Stinson advised he was receiving M-15 from Missouri Surplus.**



**Wiley Hibbard signed a contract to accept 13 M 1.6-2 M1/34 riffles from surplus, John Lake seconded. Motion passed.**






