The Ralls County Commissioners discussed road maintenance with Danny Clark, Road and Bridge Supervisor.



1. That twelve (12) residents, being partly of Center Township and partly of Jasper Township, made Application for the Vacation of a Road which begins at the Northwest corner of the Southwest Quarter (SW-1/4) of Section Twelve (12), Township Fifty-Four (54) North, Range Six (6) West, Ralls County, Missouri, and runs East along the centerline of said Section Twelve (12) a distance of one-half (1/2) mile to the center of said Section Twelve (12). Said Application for Vacation of that road was filed with this Commission on or about February 6, 2017.

2. That the Application to close said public road was publicly read at a meeting of this Commission on April 6, 2017, which was the first day of the Term after which it was presented.

3. That Notices of the filing of such Petition and of the road sought to be vacated were posted up in not less than three (3) public places in Jasper Township and three (3) public places in Center Township at least twenty (20) days before July 3, 2017, which was the first day of the next Term of this Commission. The Ralls County Commissioners received the semi-annual settlement from Jena Epperson, County Treasurer.



Sydney Ruhl met with the Ralls County Commissioners regarding flooding in Ralls County this spring and summer.


Robert Fergeson from the Federal Emergency Management Agency (FEMA) met with the Ralls County Commissioners.
