The Ralls County Commission had a phone conference with Charlene Smith from FEMA about the 2019 Flood Disaster.


The Ralls County Commission received a letter from University of Extension about a change in voting districts & their budget for the month of June 2020.

Dear Ralls County Commission:


The University of Missouri Extension Council – Ralls County decided to change the voting districts for the election of council members. The old voting districts were based on the seven townships in the county. The last few years it has been difficult to get candidates to run for the extension council from some of the voting districts. We believe a change in population density across the county over the last several decades has contributed to this problem.

The extension council now proposes to have only two voting districts. District 1 will comprise the same area as the current eastern county commission district. District 2 will be the same as the western county commission district. We will have five elected candidates from each voting district. Additionally, four candidates will be elected at-large from the county. The appointed position from the town of New London will be discontinued. All other appointed positions will remain the same.

These new voting districts will go into effect for the January 2021 election.






