
The Ralls County Commission signed accounts payable as listed in the warrant registry.

The Ralls County Commission signed a letter supporting the Hannibal bypass.


The Ralls County Commission signed a letter to Governor Parsons requesting a call for special sessions to address the issues that would correct HB527 and SB37.



The Ralls County Commission signed a letter in support of the Hannibal Bypass.



Brian Untiedt from MoDot met with the Ralls County Commission about Owendale, Hannibal Bypass and Scott's Lane.


Lynn Hodges, RCEC, gave the Ralls County Commission a proposal about extending the broadband network within Ralls County.

The Ralls County Commission discussed road maintenance.


John Lake made a motion to hire Darren Sharkey as a full time employee for Road and Bridge. Junior Muehring seconded the motion. Motion passed unanimously.
