The Ralls County Commission discussed road maintenance.


Ralls County Commission signed a Lake Hour contract with CORP of Engineerings for the year 2021.

The Ralls County Commission sent a letter to a resident in the Ralls County advising him to remove the gates at Red Barn Road.




Gary Million from John Deere met with the Ralls County Commission and the commission signed paperwork for the new graders.


