Sheriff Dinwiddie & Chief Deputy Haught met with the Ralls County Commission about things happening in the county.


EMD, Eric Murfin, met with the Ralls County Commission about COVID-19.

The Ralls County Commission signed accounts payable as listed in the warrant registry.



The Ralls County Commission had a phone conference with Tanya Taylor, Director of the Ralls County Health Department.




