**The Ralls County Commission reviewed the 2020 Annual Settlement, from Collector Tara Comer.**


**Jayme Lane requested to use the old jail parking lot for New London Park Days. Commission approved that the New London Park Board could use the parking lot that weekend.**

**Mike Huff met with the Ralls County Commission about two Conditional use permits submitted by attorney Casey Welch on behalf of his client, James Wisdom.**






