
Prosecuting Attorney Rodney Rodenbaugh met with the Ralls County Commission regarding the Knox Stone Company planning and zoning decision.

The Ralls County Commission spoke via telephone with Little Dixie Construction regarding the road damage created on Trabue Lane by their building project.


The Ralls County Commission spoke via telephone with Representative Chad Perkins regarding Grain Belt.

RE: Inspection of Precinct Report

In accordance with 51.121 RSMo, I have inspected each precinct, reviewed the described boundary lines, and surveyed the number of voters in each. Careful consideration has also been given to voter convenience, safety, parking availability, handicap accessibility, and other statutory requirements.

Currently, the breakout of voters by polling location is as follows:

The only change in polling locations that has been made recently is in Spencer Township. The New London Lions Club flooded in early 2021 resulting in Spencer's polling location temporally closing. After using McDonald Stone Co. for the April 2021 election, we ultimately relocated back to New London Lions Club after renovations were finished. This facility has ample parking, is handicap accessible, and offers amenities for both voters and the judges such as rest rooms and kitchen facilities. The New London Lions Club also has an ideal floor plan to allow for traffic flow of voters in and out of the polling place and a secure voting area.

All other polling places remain in good condition and continue to adequately serve the voters of Ralls County for the purpose of voting.

I appreciate your continued input and cooperation with the election process.

Alan Brothers spoke with the Ralls County Commission with concerns about the bridge in Ilasco.



The Ralls County Commission discussed road maintenance.




