

The Ralls County Commission received the additions and abatements from the Ralls County Collector, Connie Berry.


The Ralls County Commission received the Circuit Court Distribution Report from the Circuit Clerk, Gina Jameson.

Ralls County Commissioners discussed road maintenance with Danny Clark, Road and Bridge Supervisor.


The Ralls County Commission signed payroll and warrants as listed in the warrant registry.












John Lake made a motion to accept the bid from Farmers and Merchants Bank. RC Harlow seconded the motion. Motion passed.
