The Ralls County Commissioners signed checks and the warrant registry for Accounts Payable.


Chief Deputy Ron Haught called and talked with Ralls County Commissioners regarding issues going on in the county.





John Lake made a motion to amend the Assessors Budget. RC Harlow seconded.




Wiley Hibbard made a motion to sell surplus 1998 4x4 Dodge truck. John Lake seconded. Motion passed.


