Rodney Rodenbaugh, Prosecuting Attorney, met with the Ralls County Commission about planning & zoning.


The Ralls County Commission were informed that the Solid Waste Management has grants up to \$3,500 available to reduce waste going into the landfills.

David Colburn met with the RC commission about his position with Road & Bridge. The commission talked with him about his CDL and a time frame to start.



NOTICE OF HEARING

A hearing will be held at September 10th, 2020 at 10:00 a.m., in office of the County Clerk, Ralls County Courthouse, New London, Missouri, at this time citizens may be heard on the property tax rate proposed to be set by the Ralls County Commission for Ralls County.

The tax rates shall be set to produce the revenue, which the budget for the fiscal year beginning January 1, 2021 shows to be required from the property tax. Each tax rate is determined by dividing the amount of the revenue required by the current assessed valuation. The result is multiplied by one hundred so that the tax rate will be expressed in cents per one hundred dollar valuation.

RC Harlow made a motion to accept bid for concrete on Janapas Trail. John Lake seconded. Motion passed.


