Ralls County Commission met with Treasurer, Jena Epperson concerning the Community Development Block Grant (CDBG).


The Ralls County Commission received the Liquidity and Investment Report for August from the Treasurer, Jena Epperson.


John Lake made a motion to appoint Wiley Hibbard to the University of Missouri Extension Council. Junior Muehring seconded the motion. The motion passed unanimously.

Lynn Hodges, RCEC Director, met with the Ralls County Commission concerning power line easements.


Ralls County Commission contacted the Clinton County Commission concerning the meeting at the Governor's office this Wednesday.

Wiley Hibbard, Junior Meuhring, and Sandy Lanier met with Ameren on Scott's Lane.


Lynn Hodges from Ralls County Electric Cooperative met with the Ralls County Commission about Rescue Funds.


Wiley Hibbard made a motion to go into closed session for employee interview. Junior Muehring seconded the motion. Motion passed unanimously.
