A RESOLUTION OF THE COMMISSION OF THE COUNTY OF RALLS, MISSOURI, CALLING FOR THE JOINT ESTABLISHMENT OF A TRANSPORTATION DEVELOPMENT DISTRICT WITH THE COUNTY OF MARION, MISSOURI; AUTHORIZING THE COUNTY OF RALLS, MISSOURI TO JOIN IN A PETITION TO CREATE THE TRANSPORTATION DEVELOPMENT DISTRICT; AND AUTHORIZING CERTAIN OTHER ACTIONS

WHEREAS, the County of Ralls, Missouri (the "County") is a local transportation authority within the meaning of Section 238.202.1(4) of the Missouri Transportation Development District Act, Sections 238.200 to 238.280 of the Revised Statutes of Missouri, as amended (the "Act"); and

WHEREAS, two or more local transportation authorities are authorized under Section 238.207.5 of the Act to adopt resolutions calling for the joint establishment of a transportation development district for the purpose of funding, promoting, planning, designing, constructing, improving, maintaining, and operating one or more projects or assisting in such activity in accordance with the Act; and

WHEREAS, the County wishes to join with the County of Marion, Missouri ("Marion County"), and the Northeast Missouri Economic Development Council, doing business as the Hannibal Regional Economic Development Council ("HREDC"), in filing a Petition for the Creation of a Transportation Development District in substantially the form of Exhibit A, attached hereto and incorporated herein by reference (the "Petition"), to create the Hannibal Expressway Transportation Development District (the "District") for the purpose of funding, promoting, planning, designing, constructing, improving, maintaining, and operating one or more projects or assisting in such activity (as further defined in the Petition, the "Transportation Project"); and

WHEREAS, the Petition provides that, subject to approval of the qualified voters within the District, the Transportation Project will be funded initially through the imposition of a transportation development district sales tax (the "Sales Tax") at a rate of not to exceed one half of one percent (0.5%) for a period of up to 25 years on the receipts of all retail sales made in the District which are subject to taxation pursuant to Section 238.236 of the Act; and

WHEREAS, the County desires to cooperate with Marion County, HREDC and, upon its formation, the District for the purpose of carrying out the planning, development, acquisition, construction, and financing of the Transportation Project.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE COUNTY OF RALLS, MISSOURI, AS FOLLOWS:

- Section 1. The Board of Commissioners of the County hereby calls for the joint establishment of the District for the purpose of undertaking the Transportation Project through the imposition of the Sales Tax in accordance with the Act.
- Section 2. The Board of Commissioners of the County hereby approves the Transportation Project, and authorizes the County to join with Marion County and HREDC in the filing of the Petition with the Marion County Circuit Court.
- Section 3. The Board of Commissioners of the County hereby approves the form of Petition in substantially the form of Exhibit A, attached hereto and incorporated herein by reference, and



authorizes the County to file the Petition with the Circuit Court of Marion County, Missouri to seek qualified voter approval of the District, the Transportation Project, and the Sales Tax.

Section 4. The Board of Commissioners of the County hereby authorizes and directs Armstrong Teasdale LLP to execute the Petition and to take all such other steps as are necessary to create and implement the District in accordance with the Act.

Section 5. All actions heretofore taken by the Presiding Commissioner and any authorized officials, officers, representatives, agents, and employees of the County in connection with the transactions contemplated by this Resolution are hereby confirmed and approved, and County shall, and the officials, officers, representatives, agents, and employees of the County are hereby authorized and directed to, take such further action, and execute and deliver such other documents and instruments as may be necessary or desirable to carry out and comply with the intent of this Resolution.

Section 6. The portions of this Resolution shall be severable. In the event that any portion of this Resolution is found by a court of competent jurisdiction to be invalid, the remaining portions of this Resolution are valid, unless the court finds the valid portions of this Resolution are so essential and inseparably connected with and dependent upon the void portion that it cannot be presumed that the Board of Commissioners of the County would have enacted the valid portions without the invalid ones, or unless the court finds that the valid portions standing alone are incomplete and are incapable of being executed in accordance with the legislative intent.

Section 7. This Resolution shall be in effect immediately following its passage by the Board of Commissioners of the County and its execution as provided by law.

PETITION FOR THE CREATION OF A TRANSPORTATION DEVELOPMENT DISTRICT

COME NOW Petitioners and, pursuant to the Missouri Transportation Development District Act, Sections 238.200 to 238.280 of the Revised Statutes of Missouri, as amended (the "TDD Act" or "Act"), petition this Court for the purpose of creating a transportation development district (the "District"), and in support state as set forth herein.

THE PARTIES

- 1. Petitioner Northeast Missouri Economic Development Council, doing business as the Hannibal Regional Economic Development Council ("HREDC") is a Missouri nonprofit corporation duly organized and in good standing under the laws of the State of Missouri, including without limitation the Missouri Nonprofit Corporation Act, Chapter 355 of the Revised Statutes of Missouri, as amended.
- 2. Petitioner County of Marion, Missouri ("Marion County" or "Marion"), acting by and through its County Commission and in its capacity as a "local transportation authority" within the meaning of Section 238.202.1(4) of the TDD Act, is acting in its official capacity pursuant to Section 238.207.5 of the TDD Act.
- 3. Petitioner County of Ralls, Missouri ("Ralls County" or "Ralls" together with Marion County or Marion, being collectively referred to herein as the "Counties"), acting by and through its County Commission and in its capacity as a "local transportation authority" within the meaning of Section 238.202.1(4) of the TDD Act, is acting in its official capacity pursuant to Section 238.207.5 of the TDD Act.

- 4. Respondent Missouri Highways and Transportation Commission (the "Commission") is the constitutional authority responsible for constructing and maintaining the highway system of the State of Missouri, and is a necessary party under Section 238.207.5(3)(c) of the TDD Act.
- 5. Respondent City of Hannibal, Missouri ("Hannibal") is a political subdivision of the State of Missouri, a "local transportation authority" within the meaning of Section 238.202.1(4) of the TDD Act, and a necessary party under Section 238.207.5(3)(c) of the TDD Act.
- 6. Respondent City of Palmyra, Missouri ("Palmyra") is a political subdivision of the State of Missouri, a "local transportation authority" within the meaning of Section 238.202.1(4) of the TDD Act, and a necessary party under Section 238.207.5(3)(c) of the TDD Act.
- 7. Respondent City of Center, Missouri ("Center") is a political subdivision of the State of Missouri, a "local transportation authority" within the meaning of Section 238.202.1(4) of the TDD Act, and a necessary party under Section 238.207.5(3)(c) of the TDD Act.
- 8. Respondent City of New London, Missouri ("New London") is a political subdivision of the State of Missouri, a "local transportation authority" within the meaning of Section 238.202.1(4) of the TDD Act, and a necessary party under Section 238.207.5(3)(c) of the TDD Act.
- 9. Respondent City of Perry, Missouri ("Perry") is a political subdivision of the State of Missouri, a "local transportation authority" within the meaning of Section 238.202.1(4) of the TDD Act, and a necessary party under Section 238.207.5(3)(c) of the TDD Act.

- 10. Respondent City of Monroe City, Missouri ("Monroe City") is a political subdivision of the State of Missouri, a "local transportation authority" within the meaning of Section 238.202.1(4) of the TDD Act, and a necessary party under Section 238.207.5(3)(c) of the TDD Act.
- 11. Respondent Village of Rensselaer, Missouri ("Rensselaer") is a political subdivision of the State of Missouri, a "local transportation authority" within the meaning of Section 238.202.1(4) of the TDD Act, and a necessary party under Section 238.207.5(3)(c) of the TDD Act.

PETITION REQUIREMENTS

- 12. Petitioners desire to create the District for the sole purpose of funding, promoting, planning, designing, constructing, improving, maintaining, and operating one or more "projects" within the meaning of Section 238.202.1(5) of the Act or assisting in such activity (the "Transportation Project"), which Transportation Project is described in Paragraph 19 of this Petition for the Creation of a Transportation Development District (this "Petition").
- 13. The name of each local transportation authority within the proposed District is as follows: Marion County, Ralls County, Hannibal, Palmyra, Center, New London, Perry, Monroe City and Rensselaer.
- 14. The names of the local transportation authorities affected by the Transportation Project are as follows: Marion County, Ralls County, Hannibal, Palmyra, Center, New London, Perry, Monroe City and Rensselaer.
- 15. The resolution of the governing body of each local transportation authority calling for the joint establishment of the District pursuant to Section 238.207.5 of the TDD Act, is set forth as **Exhibit A**, attached hereto and incorporated herein by reference.

- 17. The proposed boundaries of the District are boundaries of Marion County and Ralls County, all located in the State of Missouri. A specific description of the proposed boundaries of the District and a map illustrating such boundaries are set forth in **Exhibit B and Exhibit C**, respectively, attached hereto and incorporated herein by reference.
 - 18. The proposed District is contiguous within the meaning of Section 238.207.5(2) of

the TDD Act.

- 19. Petitioners propose that the Transportation Project be undertaken by the District. A general description of the Transportation Project is as follows: enhancements and upgrades along the U.S. Highway 61 corridor from its intersection with Missouri Route 19 located south of New London to its intersection with Missouri Route 168 located north of Palmyra, including without limitation a new section of U.S. Highway 61 within the boundaries of the District to create an expressway to the west of Hannibal. The approximate location of the Transportation Project is as follows: within the boundaries of Marion County and Ralls County.
- 20. The name of the proposed District will be the Hannibal Expressway Transportation Development District.
- 21. The board of directors of the District will be composed of nine (9) members, which shall consist of the presiding officer of Marion County, Ralls County, Hannibal, Palmyra, Center, New London, Perry, Monroe City and Rensselaer.
- 22. The terms of office of the board of directors of the District shall coincide with the terms of office of the presiding officers of Marion County, Ralls County, Hannibal, Palmyra, Center, New London, Perry, Monroe City and Rensselaer and, upon the assumption of office of a new officer of one of the aforementioned counties or cities, such individual shall automatically succeed his or her predecessor as a member of the board of directors of the District. Upon the removal, resignation or disqualification of such person, the governing body designating such person shall designate a successor director.
- 23. MHTC shall appoint one or more advisors to the board of directors of the District as provided in Sections 238.220.4 of the TDD Act.
- 24. The Transportation Project will be funded initially through the imposition of a transportation development district sales tax (the "Sales Tax") pursuant to Section 238.236 of

the TDD Act. Pursuant to the TDD Act, the proposed District may impose the Sales Tax upon approval of the qualified voters within the proposed District at a rate of one-eighth of one percent, one-fourth of one percent, three-eighths of one percent, one-half of one percent or one percent on the receipts from the sale at retail of all tangible personal property or taxable services at retail within the proposed District, if such property and services are subject to taxation by the State of Missouri pursuant to the provisions of Sections 144.010 to 144.525 of the Revised Statutes of Missouri, as amended. The Petitioners desire to seek the approval of the qualified voters of the imposition of the Sales Tax at a rate not to exceed one half of one percent (0.5%) for a period up to 25 years from the date the Sales Tax is first imposed, to (a) pay the costs of the Transportation Project; (b) reimburse the Petitioners for the costs of filing and defending this Petition as authorized by Section 238.217 of the TDD Act; and (c) to pay the proposed District's reasonable and actual cost of administering, collecting, enforcing and operating the proposed District, including without limitation costs incurred pursuant to Sections 238.222, 238.252, 238.255 and 238.272 of the TDD Act.

- 25. Pursuant to Section 238.212 of the Act, the Circuit Clerk of this Court shall give notice to the public by causing one or more newspapers of general circulation serving the Counties or portions thereof contained in the proposed District to publish once a week for four consecutive weeks a notice in substantially the form as provided in Section 238.212 of the Act.
- 26. Petitioners desire that this Court also order one or more public hearings on the question of the creation and funding of the proposed District under such terms and conditions as this Court deems appropriate and that notice of such public hearing(s) be given in the notice specified in Section 238.212.1 of the Act.
- 27. The proposed District will not be an undue burden on any owner of property within the District and is not unjust or unreasonable.

WHEREFORE, the Petitioners request that this Court enter a judgment and decree pursuant to the TDD Act as follows:

- A. Finding and certifying that this Petition is not legally defective and that the Respondents has been duly served with process in this action;
 - B. Finding and certifying that the proposed District is contiguous;
- C. Finding and certifying that the proposed District is not an undue burden on any owner of property within the District and is not unjust or unreasonable;
- D. Finding and certifying that the proposed District, the development of the proposed Transportation Project, and the proposed funding method are neither illegal nor unconstitutional;
- E. Certifying the single question regarding creation of the proposed District, development of the proposed Transportation Project, and proposed funding of the Sales Tax for qualified voter approval pursuant to Section 238.210.2 of the TDD Act, which single question shall be in substantially the form provided in Section 238.215.3 of the TDD Act;
- F. Calling for an election pursuant to Section 238.216.1 of the TDD Act and ordering the county clerks of Marion County and Ralls County to cause the single question to appear on the ballot on the next regularly scheduled general, primary, or special election day, which date shall be the same in each county included within and voting upon the proposed District;
- G. Ordering the Circuit Clerk of Marion County, District 2, Hannibal, Missouri, to give notice to the public by causing one or more newspapers of general circulation serving the counties contained in the proposed District to publish once a week for four consecutive weeks a notice substantially in the form provided in Section 238.212.1 of the TDD Act; and
- H. Ordering one or more public hearings on the single question of creation of the proposed District, development of the proposed Transportation Project, and proposed funding of

the Sales Tax, which public hearing(s) shall be held at such time(s), date(s) and place(s) as this Court deems necessary and proper.

Petitioners further request this Court make any additional findings and orders and grant such other further relief which this Court deems necessary and proper.


